MEMORANDUM OF UNDERSTANDING BETWEEN

PRAGJYOTISH COLLEGE, GUWAHATI – 781 009 AND

ACADEMY OF KARATE ATHLETE, GUWAHATI - 781 025

This Memorandum of Understanding (herein after referred to as MoU) is entered into on 03rd May, 2023 between PRAGJYOTISH COLLEGE (herein after referred to as PC, located at Santipur, Bharalumukh, Guwahati – 781 009) and Academy of Karate Athlete (herein after referred to as AKA, located at Fatashil, Ganeshpara, Guwahati – 781 025)

The scope of the MoU, the roles and responsibilities of the parties of the MoU are given below:

ALLIANCE OBJECTIVE:

This document outlines a strategic understanding between PC and AKA, with the primary aim to improve the physical, mental health and improvement of self-awareness, of multiple stakeholders, primarily the youth section, who are bona fide students of Pragjyotish College, and students (of any age group) who belong to the fringe area communities of Pragjyotish College.

AREAS OF COLLABORATION:

AKA will provide the necessary activity/ service/ training requested by PC at the college premises, through experienced professionals and experts. PC will arrange/provide/maintain a safe environment for the activity/ service/ training requested from AKA, for maximum benefit of the student community of the college in* general, and social benefit of the communities, as defined in the Community Development Policy of PC.

MONITORING OF ACTIVITY/ SERVICE/ TRAINING:

All activity/ service/ training organized from time to time will be monitored through the Community Development Cell (CDC) of PC. The CDC shall maintain records of various activity/ service/ training organized from time to time, and shall also coordinate with AKA for planning and execution of the same.

GENERAL TERMS AND CONDITIONS:

- 1. Both parties will be bound by and adhere to mutually agreed upon Terms and Conditions
- 2. AKA shall undertake training programs for the girls' hostel inmates of PC, from time to time on paid/ voluntary basis (as agreed upon by both the parties)
- 3. AKA shall undertake training programs for the non-residential students (any gender) of PC, from time to time on paid/voluntary basis (as agreed upon by both the parties)
- 4. AKA shall undertake training programs for student community of the fringe areas of PC, from time to time, on paid/voluntary basis (at the discretion of AKA)
- 5. This MoU shall be in effect for a period of five (5) years from the date of signing, unless terminated by either party, through a prior notice of one (1) month, if either of the parties is dissatisfied by reasons beyond its control from going ahead with the implementation of the provisions of this MoU.
- 6. There shall be no liability on the part of any party to the other arising from the termination of this MoU.
- 7. The duration of the various activity/ service/ training organized from time to time shall be determined by mutual consensus between both the parties.
- 8. AKA will pay a nominal amount of Rs. 1000/- per month towards the maintenance expenses of the college campus

- 9. Any Course Certificate provided to the students of PC, will be jointly signed by both the parties
- Any promotional material made, electronic or print or 10. otherwise, with the intent of publicity, shall be done with the prior approval and knowledge of the institutional authorities

SIGNATURES:
