PRAGJYOTISH COLLEGE, Accredited by NAAC since 2004 (3rd Cycle), Recognised under sections 2(f) and 12(B) of UGC, Affiliated to Gauhati University, which expression shall, unless repugnant to the context or meaning thereof, be deemed to include its successors and permitted assigns of the SECOND PART;

WHEREAS:

- A. **YUVAAN EDUCATIVE LLP** is engaged in imparting National Skills Qualification Framework (NSQF) aligned skill development courses in various trades including Retail Management, Tourism & Hospitality, Beauty & Wellness, IT/ITeS, Electronics & Hardware, Agriculture & Horticulture, Private Security, Healthcare, Agriculture (Dairy Farming), Automotive, and Apparels.

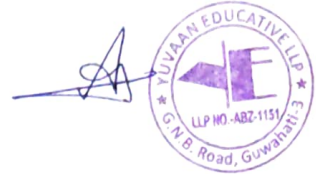
