



MEMORANDUM OF UNDERSTANDING BETWEEN

**PRAGJYOTISH COLLEGE,
GUWAHATI – 781 009**

AND

**SAVE BHARALU (BHARALU BACHAO) ABHIYAN,
GUWAHATI – 781 019**

This Memorandum of Understanding (herein after referred to as MoU) is entered into on 19th May, 2023 between **PRAGJYOTISH COLLEGE** (herein after referred to as PC), located at Santipur, Bharalumukh, Guwahati – 781 009 and **SAVE BHARALU (BHARALU BACHAO) ABHIYAN** (herein after referred to as SBA), located at Janakpur, Kahilipara, Guwahati – 781 019.

The scope of the MoU, the roles and responsibilities of the parties of the MoU are given below:

1. ALLIANCE OBJECTIVE:

This document outlines a strategic understanding between PC and SBA, with the primary aim to undertake measures for bringing about proactive and qualitative changes in the context of Bharalu river degradation. The jurisdictional area shall include the stretch spanning from the confluence of the Bharalu-Brahmaputra (north of the Bharalu Police Station) up to the Bharalu bridge located in the Bishnupur Main Road.

2. AREAS OF COLLABORATION:

Both PC and SBA will plan and execute efforts in respect of the following domains of action:

- Cleanliness drives
- General public awareness programs
- Tree plantation drives
- Adoption of preventive measures for solid waste dumping
- Observation of events of national and international significance

3. EXECUTION AND MONITORING OF ACTIVITIES:

All activities planned and executed within the domain of the various areas of collaboration (as stipulated in Section 2 above), shall be executed through one or all of the following modes:

- Collaboration between SBA and different institutional units of PC (Internal Quality Assurance Cell, National Service Scheme and Community Development Cell)
- Collaboration between SBA, PC and other governmental agencies like Guwahati Municipal Corporation, District Administration, Forest Department, etc.
- Collaboration between SBA, PC and the adopted schools of PC
- Collaboration between SBA, PC and the different MoU partner HEIs of PC
- Distribution of print and audio-visual material amongst general public
- Erection of signages along vantage points of the Bharalu river
- Proactive initiatives through student vigilant groups (*Swacchata Prahari*) for prevention of solid waste dumping in the river and littering of the river banks
- Organization of brainstorming sessions, workshops, lectures, rallies and any other programs relevant to the Alliance Objectives and Areas of Collaboration as stated above


4. GENERAL TERMS AND CONDITIONS:

1. Both parties will be bound by and adhere to mutually agreed upon Terms and Conditions
2. This MoU shall be in effect for a period of five (5) years from the date of signing, unless terminated by either party, through a prior notice of one (1) month, if either of the parties is dissatisfied by reasons beyond its control from going ahead with the implementation of the provisions of this MoU.
3. There shall be no liability on the part of any party to the other arising from the termination of this MoU.
4. The duration of the various activity/ service/ training organized from time to time shall be determined by mutual consensus between both the parties.
5. Any Certificate provided to the students of PC, will be jointly signed by both the parties
6. Any promotional material made, electronic or print or otherwise, with the intent of publicity, shall be done with the prior approval and knowledge of both the parties


